Subject - Notice inviting applications for appointment of Assistant coach- Judo on contract basis for Khelo India State Centre of Excellence at G V Raja Sports School

3. Selection Procedure

- Through interview including oral test for discipline specific knowledge. In case of candidate are more than five times the vacancy, short listing of candidates for interview shall be carried out and on the basis of approved criteria. Hence mere fulfillment of eligibility criteria does not entail the candidate to be called for the interview.
- The list for eligible candidates for interview will be intimated directly from DSYA.
- The candidates should note that their candidature at all the stages will be purely professional subject to the prescribed eligibility criteria. If on verification at any stage before or after interview, it is found that they do not fulfill any of the eligibility conditions their candidature will be cancelled by DSYA.

4. The other Terms and Conditions shall be as given below :-

4.1. The applications received will be scrutinized and candidates found eligible & shortlisted will be called for an Interview at cost to the applicant in the ratio 1:5. Based on the marks obtained in the essential qualifications.

4.2. **Tenure:** - The contractual engagement will be for a period of one year and on the basis of satisfactory performance, periodic reviews, result oriented, etc. shall be extended and at all times coterminous with the Khelo India Scheme.

4.3 **Age Limit:** - The maximum age shall not be more than 40 years on the last date of submission of applications.

4.4 **Remuneration :** - Fixed monthly remuneration of Rs. 40,000/-

4.5 **Tax Deduction at source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Directorate of Sports & Youth Affairs will issue TDS Certificates/Service Tax, as applicable.

4.6 **Other Allowances:** - No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance /Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible to them.

4.7 **Extension:** - Performance of the Assistant Coach would be continuously reviewed and their extension will be considered on the basis of performance review reports.

4.8 **Leave:** - They will be entitled for 30 days leave in a calendar year on pro-rata basis. Un-availed leave in a calendar year will lapse and will not be carry- forwarded to the next calendar year.

4.9. **Confidentiality:** -

1. Assistant Coach may not, except with the previous sanction of Directorate of Sports & Youth Affairs in the bonafide discharge of his/her duties, publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymously in the name of any other person, if such book, article, broadcast, uses any information that he/she may gather as part of this assignment, without the prior approval of the Directorate of Sports & Youth Affairs.
2. During the period of engagement with DSYA, the Assistant Coach would be subjected to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by his/her during the period of his/her engagement to anyone who is not authorized to know.
3. The Assistant Coach engaged by the Directorate of Sports & Youth Affairs shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of Directorate of Sports & Youth Affairs .

4. Other Conditions: -

- 4.1. The applications received will be scrutinized/ shortlisted on the basis of relevant experience and job description and the eligible candidates will be called for Interview at cost to the applicant
- 4.2. In case he/she is required to proceed outstation from the place of posting on tour for official duty, he/she will be entitled to TA/DA as admissible under the rules
- 4.3. In case of performance of any Assistant Coach is not found satisfactory Directorate of Sports & Youth Affairs reserves the right to terminate the contract by giving thirty days notice to his/her and also Directorate of Sports & Youth Affairs may withdraw offer at any time without assigning any reason.
- 4.4. Without any prejudice to the above condition, the candidate will be terminated from his services with immediate effect without any obligations, in case the candidate is found guilty of violating any of the conditions contained in the terms of employment or is guilty of any misconduct including negligence of duties, unauthorized absence, etc.
- 4.5. Decision of Directorate of Sports & Youth Affairs in all matters regarding eligibility, selection and posting would be final and binding upon all candidates. No representation or correspondence will be entertained by Directorate of Sports & Youth Affairs in this regard.
- 4.6. DSYA reserves the right to cancel the advertisement and/or the selection process at any stage without assigning any reason.
- 4.7. The Directorate of Sports & Youth Affairs shall be the final authority in case of any issue arising out of the contractual engagement.
- 4.8. This appointment will be on contract basis and does not confer any right to claim to permanent employment in Directorate of Sports & Youth Affairs.
- 4.9. Any litigation matters pertaining to employment at Directorate of Sports & Youth Affairs shall be restricted to the jurisdiction of the Directorate of Sports & Youth Affairs courts.
