Directorate of Sports & Youth Affairs invites applications online for engagement of (01) Nutritionist on contract basis initially for a period of two years for support in its various activities in the field of Sports Management, General Management, etc for the Khelo India State Level Excellence Centre at G V Raja Sports School, Thiruvananthapuram.

1. Job Description

- Maintain the data of material/resources to manpower engaged in KISCE
- Assisting, coordinating and managing the implementation of KISCE Scheme of DSYA
- All work related to administration at KISCE
- Coordinating with different departments in queries related to KISCE
- Drafting of letters, file noting, orders, etc.
- Any other work assigned by the reporting authority
- General:
 - Good knowledge of Computers- Windows and Microsoft Office applications especially MS Word, MS Excel
 - Confident, self-driven and team player
 - Ability to read, write and speak in English, Hindi and Malayalam.

2. Qualifications:

1. Master Degree in Food and Nutrition / Home science with specialization in Nutrition / Sports Nutrition or equivalent from recognized university.

2. Minimum 8 year of working in relevant field out of which minimum 2 years of working experience with sports person.

Desirable:- 1. Certificate in Sports nutrition from recognized institution. 2. Experience in budgeting of menus 3. Preference will be given to candidates with experience of working with sports person

3. The other Terms and Conditions shall be as under :-

3.1. The applications received will be scrutinized and candidates found eligible & shortlisted will be called for an Interview at cost to the applicant in the ratio 1:5 . Based on the marks obtained in the essential qualifications.

3.2. **Tenure:** - The contractual engagement will be for a period of four years on the basis of satisfactory performance, periodic reviews, result oriented, etc. and at all times coterminous with the Khelo India Scheme.

3.3. **Age Limit:** - The maximum age shall not be more than 50 years on the last date of

receipt of applications.

- 3.4. **Remuneration** : - Fixed monthly remuneration of Rs. 75,000/- to Rs.1,00,000/-
- 3.5. **Tax Deduction at source**: The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Directorate of Sports & Youth Affairs will issue TDS Certificates/Service Tax, as applicable.
- 3.6. **Other Allowances**: - No TA/DA shall be admissible for joining the assignment or on its completion. No other facilities like DA, Accommodation, Residential Phone, Conveyance /Transport, Personal Staff, Medical reimbursement, HRA and LTC etc. would be admissible to them.
- 3.7. **Extension**: - Performance of the Young Professional would be continuously reviewed and their extension will be considered on the basis of performance review reports.
- 3.8. **Leave**: - They will be entitled for 30 days leave in a calendar year on pro-rata basis. Un-availed leave in a calendar year will lapse and will not be carry-forwarded to the next calendar year.
- 3.9. **Confidentiality**: -
 - 3.9.1 Nutritionist may not, except with the previous sanction of Directorate of Sports & Youth Affairs in the bonafide discharge of his/her duties, publish a book or a compilation of articles or participate in a radio broadcast or contribute an article or anonymously or pseudonymous in the name of any other person, if such book, article, broadcast, uses any information that he/she may gather as part of this assignment, without the prior approval of the Directorate of Sports & Youth Affairs
 - 3.9.2 During the period of engagement with Directorate of Sports & Youth Affairs , the Nutritionist would be subjected to the provisions of the Indian Official Secret Act, 1923 and will not divulge any information gathered by his/her during the period of his/her engagement to anyone who is not authorized to know.
 - 3.9.3 The Nutritionist engaged by the Directorate of Sports & Youth Affairs shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of Directorate of Sports & Youth Affairs

4. Other Conditions: -

- 1.1.1 The applications received will be scrutinized/ shortlisted on the basis of relevant experience and job description and the eligible candidates will be called for Interview at cost to the applicant
- 1.1.2 In case he/she is required to proceed outstation from the place of posting on tour for official duty, he/she will be entitled to TA/DA as admissible under the rules

- 1.1.3 In case of performance of Nutritionist is not found satisfactory Directorate of Sports & Youth Affairs reserves the right to terminate the contract by giving thirty days notice to the Nutritionist, and also Directorate of Sports & Youth Affairs may withdraw offer at any time without assigning any reason.
- 1.1.4 Without any prejudice to the above condition, the candidate will be terminated from his services with immediate effect without any obligations, in case the candidate is found guilty of violating any of the conditions contained in the terms of employment or is guilty of any misconduct including negligence of duties, unauthorized absence, etc.
